Dr Anna Cunningham - 16 occurrences. Last was paid May 1st 2025 and related to my care

Second doctor in my care - name to be provided but can be identified as always being in the meetings regarding my care. Female approx. 30's - 9 occurrences. Last was December 29TH 2024 unrelated to my care. A certain milestone is to be determined for payment to be made regarding my care. Alternatively, if you provide a list of identification via a staff number, initials or name I can identify them.

Dr Mark - replacement doctor while Anna is away - 4 occurrences. Last was December 29TH 2024 unrelated to my care. Milestone to be achieved for a new payment to be activated related to my care eg. Permanent orders over me.

Head Nurse - one of the 4 head nurses in the hospital has been paid May 1st relating to my care. Name is likely Kim - KIJ initials.

Security - Paid December 29TH by outside party unrelated to my care. Intended milestone is set to be paid for my care. If you provide their identification via a staff number or name I can identify them.

Nurses - multiple payments to 3 nurses have been paid previously by external parties. 1 nurse has been paid related to my care May 1st also. One has a milestone to achieve to be paid. If you provide their identification via a staff number or name I can identify them. Nikayla has a milestone to meet to be paid regarding my care also.

My expectation, naturally, is that The Alfred will deny all of this and assign it to mental illness on my part for consistency. However, please be aware that legal precedence allows investigation to begin on mediumship and I will be pursuing this relentlessly with the Tribunal and the police if you don't.

I'm open to compensation settlement outside the Tribunal and legal system but this is beyond inappropriate and harmful to me in multiple ways including the collapse of my business by being retained without access to police, technology and wrongfully diagnosed.

I look forward to your considered response.
